

Active Directional Strategy

- **Long & Short** *The cyclical nature of credit spreads allows a patient investor to generate returns from both rising & falling markets i.e. from both long & short risk positions.*
- **Cyclical** *The distribution of credit spreads over time is recurrent, and this allows a probabilistic approach to generate outsized returns*
- **Contrarian** *By construction the positions are often contrarian & the returns counter-correlated – performing well when other risk assets are in distress.*

Activity & Exposure History

- The Active Directional strategy can move between max short (i.e. -100% risk) to max long (i.e. 100% long risk).
- Below shows how the Active Directional strategy has moved its exposures since its live inception, often acting in a contrarian manner to most other credit market participants.
 - Gradually builds short risk during tight spreads, suppressed volatility & overextended market positioning.
 - Unwinds short risk & builds long risk during periods of high market volatility & distressed credit spreads.
